1.	A valid passport: should have been issued within the previous ten years and be valid at least 3 months after the intended date of departure from the Schengen territory or, in the case of several visits, after the last intended date of departure and should contain at least 2 empty pages when applying for the visa. Please provide one copy of the passport (the empty pages don't need to be copied).					
2.	One copy of your Chinese identity card and temporary residence card (if any) or of your residence permit (for foreigner)					
3.	One application form signed (two times: at the point nr 37 AND on the last page!) and dated by the applicant					
4.	Two recent (no more than 6-months old) passport size photographs with light-coloured background should be affixed to the application form					
5.	Original "Hukou" (no translation): with photocopies of all pages (only for Chinese nationals).					
6.	Travel Programme Documents providing clear evidences about your travel programme (booking transportation, itinerary, etc.).					
7.	Proof of accommodation: For the whole duration of the intended stay.					
8.	Flight Reservation: When applying for a visa for multiple visits: reservation of the first visit. Attention: A confirmed return ticket. The ticket should be bought only after the visa has been issued!					

9.	<p>Proof of Solvency of the applicant: Bank statements (of last 6 months showing your name and remittance of your salary/pension, no credit card statements) + copy of credit card, or travellers' checks, no deposits.</p> <p>For employee:</p> <ul style="list-style-type: none"> - A letter from the employer (in English, or in Chinese with English translation) on official company paper with stamp, signature, date and clearly mentioning: <ul style="list-style-type: none"> ▪ Address, telephone and fax numbers of the employing company; ▪ The name and position in the employing company of the countersigning officer; ▪ The name of the applicant, position, salary and years of service; ▪ Approval for leave or absence. <p>For retired persons: Proof of pension or other regular income</p> <p>For Unemployed adults: <u>If married:</u> Letter of employment and income of the spouse + Notary certificate of marriage, legalised by MFA. <u>If single/divorced/widow/widower:</u> Any other proof of regular income.</p> <p>(This should cover at least 50€/day of your whole stay in the Schengen states)</p>					
10.	Proof of property (copy of house property), translated into English / French / Dutch.					
11.	<p><u>For Minors (under 18)</u> Student card + Original letter of the school, mentioning:</p> <ul style="list-style-type: none"> ▪ Full address, telephone numbers of the school ▪ Permission for absence ▪ Name and function of the person giving the permission ▪ 1 photocopy thereof <p>Notary Certificate of birth or proof of guardianship, legalised by MFA.</p> <p>Minors travelling alone or with one parent: Notary Certificate of permission to travel from both parents or legal guardians (when minor is travelling alone) or the parent or legal guardian not travelling (if minor is travelling with one parent), translated, legalized by MFA, and when not in China, attested by the relevant authorities in the country of residence.</p>					
12.	The original of the Schengen Travel Insurance policy (should cover duration of stay + 1 day because of time difference) + 1 copy					
13.	Your e-mail address: to be mentioned on the application form					

Chinese notarized certificates have to be authenticated by the relevant Foreign Affairs Bureau of your province before being authenticated by the Embassy / Consulate General of Belgium. They should not be older than six months.

The applicant acknowledges that he has provided the documents here above marked as submitted and that he has been informed that some other documents might be requested by the Belgian Embassy / Consulate General.
